# Report Reviews (Rector's report, Deacon's report, BG&G report, etc.)

Packet given to vestry members. Nancy will present buildings and grounds reports. They have 3 top applications for lan's position.

- 1) For the 19<sup>th</sup> of May, dioceses asked if we could do the mission trip with teens to spend the night and leave Saturday. They wanted us because we're centrally located in the dioceses. We may not have a sexton available during that night. We won't have a Trinity rep for that night. Nancy says there's a youth minister from Evansville (?). We need a volunteer to come during work hours to be with the teens, show them how the building/kitchen works, etc.
- 2) The great hall door is still not repaired, but it's being worked on.
- 3) The end of May, early music society/group wants to have a big concert at Trinity (Thursday, Friday, and Saturday nights). We have until end of March to make a decision. Kevin could be paid \$150 for Thursday night and Friday night, and \$200 for Saturday night. If he chooses not to do this, we will tell them that we cannot host the concert.

### **Old Business**

Proposal for new gifts and bequests (10% buildings maintenance) - Janet

Changes since last discussed:

- 1) Proposal is limited to gifts and bequests over \$5000
- 2) We intend to honor the intent of any donors who do not want their gift or bequest subject to the 10% for building maintenance. If they insist on this, it would be included in the Gift Agreement.

# Treasurer's Report - Randy

Susan, Randy, and Andrew met to discuss changes to the format of the report, but they have not been made yet.

Randy spoke with auditor in Bedford who is completing final report of audit.

Randy requests Vestry liaisons to commissions to work with commission chairman to specify cash flow needs during different parts of the year. They received this information from the pastoral care and outreach commissions for 2023 today.

He reviewed loans for roof and mortgage. Both are due to mature in Oct 22, 2029.

Interest rate is adjustable each year, this Oct it will be adjusted again.

Roof interest rate is at 3.88%, mortgage is at 3.1%. Those rates may jump up to 6.125% for up to 3 years. Randy may have a better idea of the monthly payments for principal and interest when the rate is adjusted in July 2023.

Ron has action item to estimate what payments could be if POI is adjusted to 6.125%. Randy will provide information to support.

### Diocesan Anti-Racism Covenant - Nate

Nate provided a summary of 3 specific commitments that Trinity may partake in to implement the antiracist covenant. Nate recommends we vote to accept the covenant, and the specific commitments.

Motion passed unanimously

Nate reports on the "all lives matter" mural by TP USA. Nate attended the city Board hearing in person with Elizabeth Johnson, Anna Green, and Rev Ed Bird. Board of Public Works rejected the application, and city attorney says the application was counter to city policy. It was rejected because the new policy says that city-approved art cannot have words. TP USA threatens to sue.

Susan recommends keeping track of the lawsuit.

## Letter from AAM - Matt

Vestry received letter last week. Rev Matt says allegations are untrue, and is consulting with a personal attorney. Church insurance covers these kinds of claims, so this is effectively a lawsuit against the church. The policy covers liability up to \$1M.

Nancy recommends Vestry reach out to the parish to name their support for Rev Matt and donate to the Easter flower fund. Nancy will list all Vestry members present on the flower fund and collect additional donor names.

Motion: As senior warden, Susan asks Vestry to take this opportunity to formally express our gratitude and support for Rev. Matt's ministry at Trinity Church Bloomington.

## <u>Increase in liability insurance - Nancy</u>

Nancy had left the meeting by the time we reached this item. Susan says insurance adjuster said we need additional liability insurance.

At Vestry retreat, all Vestry members were assigned commissions. Judith will support Susan with administration and personnel. Main focus is to work with commission leadership to understand the commission's budget and help with cash flow issues.
